Classification issues were discussed due to the extra targets that are available between events. Further discussion is needed.

Synopsis of SCTP program: Youth shooting sponsored by NSSF, now SSSF in Arizona. ATA split off and now has new program AIM. NSSA/NSCA stayed with the SCTP program based on the agreement with SSSF leadership that state and national SCTP targets would be registered with the NSSA/NSCA. Further, we extend the CLM program to all SCTP participants to offset their membership fees for the first year. With no notice to our organization, SSSF changed their policy this year to state that registration of targets at the state level is" optional". Therefore, further discussions are taking place as to further direction for NSSA/NSCA support for youth shooting.

Zone Director Elections: Ballots going out middle of May and nominations for Zone EC director.

<u>Ammunition for World Shoot</u>: Having enough ammo for the World Shoot, with all the extra targets, was brought up and discussed.
