Motion by Louise Terry, **Second** by Jim Gast, to endorse Michael's proposal of defining a 5-year relationship agreement between NSSA/NSCA and SSSF for the SCTP program, and to approve implementation AFTER receiving SSSF's commitment letter for a 5-year period. SSSF must specify that targets thrown at each of their State and National Championships for SCTP will be registered with NSSA/NSCA and their SCTP shooters competing therein must be members in good standing of NSSA/NSCA. SCTP shooters will be able to take advantage of the Crossfire membership and our CLM programs to make this membership requirement more affordable for the kids.

## Our commitment:

- 1. We will dedicate up to 1 page per edition (depending on how much material is available each month) in the SSR and SC Mag
- 2. We will create an SCTP section on our MYNSSA and MYNSCA web sites to highlight the SCTP program for skeet and sporting clays
- 3. We will use the weekly TARGET TALK web newsletter to promote and publish SCTP information that we receive at HDQ.
- 4. We will analyze and correlate our Junior shooting and Youth Shooting programs with the SCTP program.
- 5. We will solicit sponsorship for annual scholarships (\$5K each one for Skeet and one for Sporting) to be awarded specifically to SCTP shooters who are also members of NSSA/NSCA criteria and process to map to our current Scholarship Programs, to be published.
- 6. We will continue to support the SCTP Nationals by supplying medals, etc., as we have done in the past.
